二、申請資格 / Eligibility

1. 具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者。

Any applicant who, at the time of application, is a foreign national, has never held a Republic of China (ROC) passport, and does not possess overseas Chinese student status.

2. 具外國國籍且符合下列規定，於申請時並已連續居留海外六年以上者(計算至 2022 年 8 月 31 日)

An applicant of foreign nationality who, pursuant to the following requirements, has continuously resided overseas for no less than 6 years (up to August 31, 2022 is also qualified to apply for admission under this regulation.

- a. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

An applicant holding both foreign and R.O.C. nationalities, but has never been registered as part of a household in Taiwan.

- b. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年(計算至 2022 年 8 月 31 日)。

An applicant holding foreign nationality, and who once held ROC nationality, but has not been registered as part of household in Taiwan for at least 8 years(up to August 31, 2022), as determined by the Ministry of Interior.

- c. 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。

If the preceding two clauses are relevant to an applicant, than that applicant must not have studied in Taiwan as an overseas Chinese student and have not been approved for student status by the University Entrance Committee for Overseas Chinese Students in the enrollment year.

依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。

According to the Agreement on Educational Cooperation, a foreign national selected by a foreign government, organization, or school, is not subject to the limitations as prescribed in the preceding two paragraphs (however, the individual will still need to obtain approval from relevant Taiwan government agencies). Please note: this is applicable only to applicants who have never been registered as part of a household in Taiwan.

3. 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者。

An applicant holding foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macau, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided in Hong Kong, Macau, or another foreign country (overseas) for no less than 6 years is qualified to apply for admission under these regulations.

4. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。

An applicant who is a former citizen of Mainland China, currently holds a foreign nationality, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided overseas for no less than 6 years is qualified to apply for admission under

these regulations.

5. 第 2 至 4 項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間，合計未逾一百二十日，連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國停留期間未逾一百二十日予以認定。

The term “overseas” as prescribed in paragraph 2~4 is limited to countries or regions other than Mainland China, Hong Kong and Macau. The phrase “continuously reside overseas” means that an individual may stay in Taiwan for a total of not more than 120 days per calendar year. If the calculated calendar year is not a complete one, the stay in Taiwan should not exceed 120 days within the calculated calendar year period.

但符合下列情形之一且具相關證明文件者，不在此限：其在國內停留期間，不併入海外連續居留期間計算。

The only exceptions to this method of calculation are as follows (Please note: these exceptions must be supported by written documentation):

- a. 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。

Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technical training classes. Please note: the courses must be Ministry of Education (hereafter referred to as the “Ministry”) accredited.

- b. 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。

Attended a Mandarin Chinese language center at a university or college in Taiwan for no more than 2 years. Please note: the educational institution must be Ministry accredited.

- c. 交換學生，其交換期間合計未滿二年。

Exchange students who have studied in Taiwan for no more than 2 years.

- d. 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

An internship lasting for no more than 2 years. Please note: the internship must be authorized by a central government agency.

6. 外國學生申請來臺就學，依第 2 至 4 項，申請入學以一次為限，於完成申請就學學校學程後，除申請碩士班以上學程，得逕本校規定辦理外，如繼續在臺就讀下一學程，其入學方式應與我國內一般學生相同。

In paragraph 2~4, Upon completion of the courses of study, if an international student intends to apply for another program at the same academic level at a school in Taiwan, the student's admission shall be handled in a manner identical to the procedure of admission for local students. In the case of applications for master's degrees or higher levels of graduate studies can the student's admission be processed under the rules of HKU.

7. 外國學生須符合教育部採認之高中、大學或獨立學院畢業者(請參考教育部國際文教處網頁 <http://www.edu.tw/bicer/>)，外國學生具高中畢業資格者，得申請入學本校學士班；具學士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校碩士班；外國學生具碩士學位者或具有與我國學制相當之同等學力資格者，得申請入學本校博士班。

International students who have graduated from a high school, college or university recognized by the Ministry of Education of the Republic of China can apply for admission (for more information, please visit: <http://www.edu.tw/bicer/>). International students with a foreign high school diploma are eligible to apply for undergraduate programs; Applicants with a Bachelor's or a Master's degree are eligible to apply for Master programs. Applicants with a Master's degree or equivalent qualifications to that of our academic degree system are eligible to apply for PhD programs.

8. 外國學生經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者，不得再依本辦法申請入學。違反規定並經查證屬實者撤銷其所獲准入學資格或開除學籍。

International students who are dismissed from schools after admission due to behavioral issues, poor academic performance or a conviction under the Criminal Law may thereafter not apply for admission under the Regulation.

9. 111 學年度申請至本校就讀之外國學生申請日期自 2021 年 10 月 15 日起，應備文件及相關規定應以中華民國教育部網站公布之最新「外國學生來臺就學辦法」之規定為準，請申請者隨時查閱教育部網站(<http://english.moe.gov.tw/content.asp?CuItem=7996>)及本校網站。

The international student application period for the fall semester of the 2021 academic year begins of October 15, 2021. Requirements and regulations can be found on the Ministry of Education (MOE) Website. The most up-to-date version of the MOE “Regulations Regarding International Students Undertaking Studies in Taiwan” is posted on the MOE website at (<http://english.moe.gov.tw/content.asp?CuItem=7996>). The highest-level diploma and transcript issued by an overseas academic institution. These documents must be authenticated by a ROC embassy, consulate, representative office, the agency authorized by the Ministry of Foreign Affairs(hereafter referred to as “Taiwan’s overseas representative office”), or verified by an institute established or appointed by, or through a private agency commissioned by, the Executive Yuan(a copy of the translation in Chinese or English is necessary if the original diploma is in language other than Chinese or English).
※Remark: If the verification process is not completed before the application deadline, a signed Affidavit (of Admissions Documents to be Verified) (See Appendix 4) must be submitted with the application. At the time of registration, students must provide the original academic degree and transcript verified by a Taiwan overseas representative office, or verified by an institute established or appointed by, or through a private agency commissioned by, the Executive Yuan. If all the required documents cannot be submitted on time, the admissions offer will be revoked.
7. 具備足夠在臺就學之財力證明書一份 (具備足夠在臺就學之財力，由金融機構核章並密封逕寄本校；未密封者，須經我國駐外館處驗證)。
A financial statement with sufficient funds (to support your study in Taiwan) and the official bank stamp. The statement should be sent to HUNGKUANG University in an envelope sealed by the bank. Unsealed financial statements shall be authenticated by a Taiwan Overseas Mission.

A copy of passport or other equivalent verification as proof of nationality.

Applicant whose mother language is not Mandarin shall submit the Certificate of TOCFL (formerly TOP), an official transcript of the Chinese language courses taken, and at least one recommendation letter from a Chinese language teacher (Appendix 6. For more information about TOCFL, please refer to the website at <http://www.sc-top.org.tw/>).

六、其他申請注意事項/Others

1. 申請人應注意申請資格、申請系所之各項規定。 Applicants may apply for a maximum of three degree programs only (filled in the order of choice) and shall abide by all the application requirements as specified

2. 報名時繳交之「畢業證書」，除海外臺灣學校及華僑學校所發者外，應依教育部「國外學歷查證認定作業要點」規定辦理。

The diploma submitted for review shall be authenticated in accordance with the rules promulgated by the R.O.C. Ministry of Education, except for diplomas issued by overseas Taiwanese schools or overseas Chinese schools.

3. 依教育部規定，凡曾遭國內大專校院退學者，不得再向本校申請入學。若違反此規定並經查證屬實者，撤銷其入學資格。

In accordance with the Ministry of Education regulations, students who had been dismissed from a university or college in the R.O.C. are not eligible to apply. Applicants who violate this regulation will have their admissions revoked.

4. 已報名或錄取之學生，如經發現申請資格不符規定或所繳交之證件有變造、偽造、假借、冒用等不實情事者，未入學者即取消錄取資格；已入學者開除學籍，亦不發給任何學歷證明；如將來在本校畢業後始發現者，除勒令繳銷其學位證書外，並公告取消其畢業資格。

If any violations to the admission qualifications or false information in the submitted documents are found, applicants will be denied admission. If already admitted, the student will be asked to leave. If already graduated, the student will be asked to return his/her diploma.

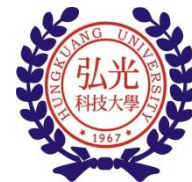

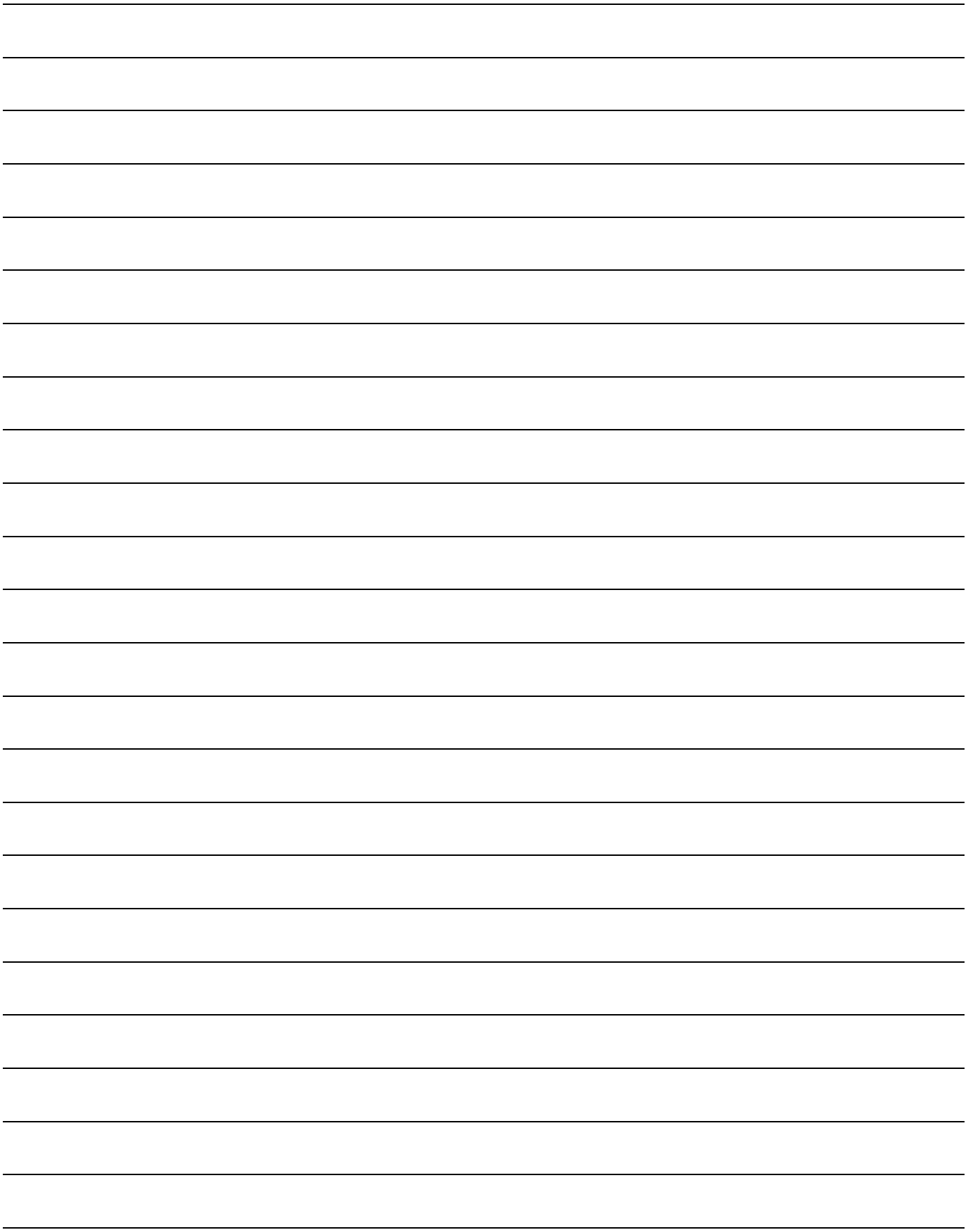
