1. 招生名額:學士:242名(四技)、36位(二技);碩士:8名;博士:3名。

Admission Quotas:

- (A) Bachelor's degree programs: 278 students.
- (B) Master's degree programs: 8 students.
- (C) Doctor's degree programs: 3 students.
- 2. 修業年限:學士班為4至6年,碩士班為1至4年,博士班為1至7年。

  Duration of study: 4 to 6 years for a Bachelor's degree program; 1 to 4 years for a Master's degree program. 1 to 7 years for a Ph.D program.
- 3. 入學時間: 秋季班(9月入學)、春季班(2月入學),每學年包含2個學期。

An academic year consists of two semesters: The first semester (Fall) begins around in the middle of September ending in the middle of January, and the second semester (Spring) begins around in the middle of February ending at the end of June.

- 4. 春季班入學與同年級一起授課,無另開班。International applicants admitted to the spring semester wil attend classes with their peers of the same grade level. No extra course is offered.
- 5. 本校授課以中文授課為主,申請人應具備基礎之中文聽、說、讀、寫之能力。

All the courses are taught in Chinese. Applicants should have adequate listening, reading, speaking and writing proficiency in Chinese at a level sufficient for academic studies.

6. 持專科學歷或大學同等學歷申請學士班一年級及轉入二年級、三年級者,本校得視其資格審查, 於註冊入學後辦理學分抵免。其學分抵免、提升編級及修業規定,悉依弘光科技大學學生抵免 學分相關辦法及本校學則辦理。 HUNGKUANG UNIVERSITY will examine applications supported by a junior college diploma or academic credentials equivalent to a college diploma, and such applicants may apply for credit transfer after being admitted as freshmen or transfer students. Affairs related to credit transfer, transferring to a higher grade level, and academic studies should be subject to the Regulations for Credit Transfer by Students at HUNGKUANG UNIVERSITY and the Academic Rules of HUNGKUANG UNIVERSITY.

#### 二、 申請資格 / Eligibility

Our admission criteria are based on *MOE Regulations Regarding International Students Undertaking Studies in Taiwan*. If the MOE (Ministry of Education) regulations are updated or changed, current regulations will apply. Please contact the MOE for the latest information.

- 1. 具外國國籍且未曾具有中華民國國籍,於申請時並不具僑生資格者。
  Any applicant who, at the time of application, is a foreign national, has never held a Republic of China (ROC) passport, and does not possess overseas Chinese student status.
- 2. 具外國國籍且符合下列規定,於申請時並已連續居留海外六年以上者(計算至 2023 年 8 月 31 日)

An applicant of foreign nationality who, pursuant to the following requirements, has continuously resided overseas for no less than 6 years (up to August 31, 2023 is also qualified to apply for admission under this regulation.

- a. 申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。
  An applicant holding both foreign and R.O.C. nationalities, but has never been registered as part of a household in Taiwan.
- b. 申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪失中華民國國籍之日起至申請時已滿八年(計算至 2023 年 8 月 31 日)。

  An applicant holding foreign nationality, and who once hold POC nationality but has not been
  - An applicant holding foreign nationality, and who once held ROC nationality, but has not been registered as part of household in Taiwan for at least 8 years(up to August 31, 2023), as determined by the Ministry of Interior.
- c. 前二款均未曾以僑生身分在臺就學,且未於當學年度接受海外聯合招生委員會分發。
  If the preceding two clauses are relevant to an applicant, that applicant must not have studied in Taiwan as an overseas Chinese student and have not been approved for student status by the University Entrance Committee for Overseas Chinese Students in the enrollment year. 依教育合作協議,由外國政府、機構或學校遴薦來臺就學之外國國民,其自始未曾在臺設有戶籍者,經主管教育行政機關核准,得不受前二項規定之限制。

According to the Agreement on Educational Cooperation, a foreign national selected by a foreign

government, organization, or school, is not subject to the limitations as prescribed in the preceding two paragraphs (however, the individual will still need to obtain approval from relevant Taiwan government agencies). Please note: this is applicable only to applicants who have never been registered as part of a household in Taiwan.

- 3. 具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門 或海外連續居留滿六年以上者。
  - An applicant holding foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macau, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided in Hong Kong, Macau, or another foreign country (overseas) for no less than 6 years is qualified to apply for admission under these regulations.
- 4. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留海外六年以上者。 An applicant who is a former citizen of Mainland China, currently holds a foreign nationality, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided overseas for no less than 6 years is qualified to apply for admission under these regulations.
- 5. 第2至4項所稱海外,指大陸地區、香港及澳門以外之國家或地區:所稱連續居留,指外國學生每曆年在國內停留期間,合計未逾一百二十日,連續居留海外採計期間之起迄年度非屬完整曆年者,以各該年度之採計期間內在國停留期間未逾一百二十日予以認定。 The term "overseas" as prescribed in paragraph 2~4is limited to countries or regions other than Mainland China, Hong Kong and Macau. The phrase "continuously reside overseas" means that an individual may stay in Taiwan for a total of not more than 120 days per calendar year. If the calculated calendar year is not a complete one, the stay in Taiwan should not exceed 120 days within the calculated calendar year period.

The only exceptions to this method of calculation are as follows (Please note: these exceptions must be supported by written documentation):

- b. 就讀教育部核准得招收外國學生之各大專校院華語文中心,合計未滿二年。 Attended a Mandarin Chinese language center at a university or college in Taiwan for no more than 2 years. Please note: the educational institution must be Ministry accredited.
- c. 交換學生,其交換期間合計未滿二年。 Exchange students who have studied in Taiwan for no more than 2 years.
- d. 經中央目的事業主管機關許可來臺實習,實習期間合計未滿二年。

An internship lasting for no more than 2 years. Please note: the internship must be authorized by a central government agency.

- 6. 外國學生申請來臺就學,依第2至4項,申請入學以一次為限,於完成申請就學學校學程後,除申請碩士班以上學程,得逕本校規定辦理外,如繼續在臺就讀下一學程,其入學方式應與我國內一般學生相同。
  - In paragraph 2~4, Upon completion of the courses of study, if an international student intends to apply for another program at the same academic level at a school in Taiwan, the student's admission shall be handled in a manner identical to the procedure of admission for local students. In the case of applications for master's degrees or higher levels of graduate studies can the student's admission be processed under the rules of HUNGKUANG UNIVERSITY.

International students with a foreign high school diploma are eligible to apply for undergraduate programs; Applicants with a Bachelor's or a Master's degree are eligible to apply for Master programs. Applicants with a Master's degree or equivalent qualifications to that of our academic degree system are eligible to apply for PhD programs.
- 8. 外國學生經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者,不得再依本辦法申請入學。違反規定並經查證屬實者撤銷其所獲准入學資格或開除學籍。 International students who are dismissed from schools after admission due to behavioral issues, poor academic performance or a conviction under the Criminal Law may thereafter not apply for admission under the Regulation.

  The international student application period for the fall semester of the 2023 academic year begins of October 24, 2022. Applicants should provide a certificate of language proficiency in Chinese when applying for admission. For admission to a Chinese-taught program, a TOCFL (Test of Chinese as a Foreign Language) certificate for Level 2 or above, or a certificate of completion of a Chinese program at Level 2 is required. Applicants who don't have a TOCFL certificate for Level 2 or above must take the Chinese courses offered by HUNGKUANG UNIVERSITY. (Native Chinese speakers are exempt from this requirement.)


