I. Enrollment and Study Duration

1. Enrollment Period: Around September of the year, with two semesters per academic year.
2. 4 to 6 years for a 4-year Bachelor's degree program; 2 to 4 years for a 2-year Bachelor's degree program; 1 to 4 years for a Master's degree program. 2 to 7 years for a Ph.D. program.

II. Admission Quotas

Bachelor's Programs: 44 students; Master's Programs: 2 students; Doctorate's Program: 1 student

III. Application Qualifications

1. Identity Qualifications:

- (1) Eligible applicants must return from overseas within the current year (excluding those already studying in high schools or universities in Taiwan, and graduates from the National Taiwan Normal University Academy Preparatory Programs for Overseas Chinese Students).
 - Overseas Chinese Students:** Students of Chinese descent born and continuously residing overseas, or having resided overseas for at least 6 consecutive years, holding permanent or long-term residence documents from the residing country.
 - Hong Kong/Macao Students:** Residents of Hong Kong or Macao holding permanent residence documents and having resided overseas for at least 6 consecutive years; must comply with Article 4 of the Laws and Regulations Regarding Hong Kong & Macao Affairs
 - Overseas Chinese Student of Foreign Nationality:** Students with foreign nationality and permanent residence in Hong Kong or Macao, without household registration in Taiwan, and having resided in Hong Kong, Macao, or overseas for at least 6 consecutive years, may

apply under Article 23-1 of the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

- (2) The term "overseas" in items (1) and (3) refers to countries or regions outside Mainland China, Hong Kong, and Macao; "overseas" in item (2) refers to countries or regions outside Taiwan.
- (3) "Consecutive years " means that the period of stay in Taiwan does not exceed 120 days in each calendar year (January 1 to December 31), calculated from the application deadline of this guide retroactively for 6 years. Applicants meeting the continuous residence requirement by August 1, 2025, are also eligible to apply.
- (4) According to Article 4 of the Laws and Regulations Regarding Hong Kong & Macao Affairs, "Hong Kong residents" are those who have permanent residency in Hong Kong and do not hold a British National (Overseas) passport or travel documents other than a Hong Kong passport; "Macao residents" are those who have permanent residency in Macao and do not hold a passport other than a Macao passport or a Portuguese passport obtained before the end of Portuguese rule in Macao. Students with foreign nationality and permanent residency in Hong Kong or Macao, without household registration in Taiwan, and having resided in Hong Kong, Macao, or overseas for at least 6 consecutive years, may apply under Article 23-1 of the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.
- (5) Regarding continuous residence and exemption regulations, refer to Articles 3 and 4 of the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan for overseas Chinese students, and Articles 3 and 4 of the Regulations for Hong Kong and Macao Residents Studying in Taiwan for Hong Kong/Macao students. Please attach the relevant proof documents when applying for admission.
- (6) Holders of permanent or long-term residence documents from their residing country can obtain recognition of overseas Chinese identity with a duly signed Taiwan passport.
- (7) **The identity of overseas Chinese students is verified by the Overseas Community Affairs Council; the identity of Hong Kong/Macao students and Hong Kong/Macao students with foreign nationality is verified by the Ministry of Education. The identity cannot be changed arbitrarily during the study period in Taiwan unless otherwise stipulated by law.**
- (8) According to Article 2 and Article 23-1 of the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan, Overseas Chinese and Hong Kong/Macao students with foreign nationality who have studied in Taiwan for less than 2 years and dropped out or lost their student status due to reasons, may reapply to study in Taiwan once. Relevant proof documents should be submitted with the application. Students expelled or dismissed due to misconduct or academic failure cannot reapply.
- (9) According to Articles 7 of the Regulations for Hong Kong and Macao Residents Studying in Taiwan, Hong Kong/Macao residents who voluntarily withdrew from studies and have stayed in Taiwan for less than 2 years may reapply to study in Taiwan once. Relevant proof documents should be submitted with the application. Students expelled for misconduct or criminal convictions cannot reapply or transfer to other schools in Taiwan.
- (10) Students who have registered, suspended, or retained admission in universities in Taiwan (including the National Taiwan Normal University Academy Preparatory Programs for Overseas Chinese Students) cannot reapply.
- (11) This admission does not include graduates from unregistered Chinese language schools in Myanmar and northern Thailand.

2. Academic Qualifications:

- (1) Graduates from senior high schools or universities in local, foreign, or Mainland China areas equivalent to Taiwan senior high schools, with diplomas **verified by Taiwan embassies or Recommendation Units Authorized by the Overseas Community Affairs Council**.
- (2) Applicants with academic qualifications equivalent to Taiwan senior high schools, completing or higher than the final year of high school or equivalent abroad, may apply for university admission under the following conditions:
 - i. Not completing the final year due to suspension, dropout, or repeating for more than two years.
 - ii. Completing the first semester of the final year and then suspending or dropping out for over a year.
 - iii. Completing the required years but unable to graduate.

Annotation 1: Applicants must submit a proof of study for verification. The calculation for suspension, dropout, or repeating years is from the last date recorded on the proof of study or suspension proof up to the registration deadline of the application year.

Annotation 2: A "certificate of leaving school" cannot be considered as a "graduation certificate" but only as a "proof of study."

Annotation 3: Graduates from equivalent to Taiwan high school second year abroad or in Hong Kong/Macao must complete 12 additional graduation credits when studying at our university.

Annotation 4: Recognition of equivalent academic qualifications should follow the Ministry of Education Standards for Recognition of Equivalent Educational Levels for University Admission.

- (3) Verification of identity and academic qualifications will be handled by the Overseas Community Affairs Council, the Ministry of Education, and our university according to relevant regulations. Applicants must complete the declaration forms and eligibility confirmation forms to facilitate the verification process. **If the qualifications are found non-compliant after admission, the admission will be canceled.**
 - i. **Declaration of Identity and Academic Qualifications:** Must be completed by Overseas Chinese Students or Hong Kong/Macao students or Hong Kong/Macao students with foreign nationality.
 - ii. **Eligibility Confirmation Form:** Must be completed by Overseas Chinese Students or Hong Kong/Macao students or Hong Kong/Macao students with foreign nationality.
- (4) Applicants who fall under any of the following circumstances will be disqualified from applying. If already admitted, they shall be required to withdraw and their student status will be revoked.
 - i. Students who have studied (completed) high school in Taiwan.
 - ii. Applicants who submit forged, misused, or altered documents or passports.
 - iii. Applicants who have applied for and renounced Taiwan nationality but have not yet obtained foreign nationality.
 - iv. Applicants whose identity qualifications are found non-compliant by the Overseas Community Affairs Council or the Ministry of Education after admission.
 - v. Applicants who have applied and studied in Taiwan under foreign student status.


IV. Application Period and Process

1. Application Period:

First batch: September 16, 2024 to December 31, 2024

Second batch: March 1, 2025 to July 4, 2025

2. Application Process:

Step 1	Confirm your eligibility as an overseas Chinese, Hong Kong/Macao student, or Overseas Chinese Student of Foreign Nationality, and decide on your intended department of study.
Step 2	Access the "Hungkuang University Admission Application System" via the provided link: https://forms.gle/GRZTWKKJGcZP8twf9 
Step 3	Enter personal data and select up to two department preferences.
Step 4	Compile the required documents into a single PDF file and upload it to the application system (place the checklist as the first page). ※Ensure all required items listed in the checklist are uploaded. Any missing items affecting the review results will be the applicant's responsibility.
Step 5	After completing the online application (including online registration and document upload), print the application confirmation document and retain it for reference.

V. Application Notes and Regulations

2. To verify the eligibility of Hong Kong/Macao students according to the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan and the Regulations for Hong Kong and Macao Residents Studying in Taiwan, part of the student's personal data will be transmitted to the University Entrance Committee For Overseas Chinese Students, the Ministry of Education, the National Immigration Agency, and the Overseas Community Affairs Council for extraction of entry and exit records. The Ministry of Education, the University Entrance Committee For Overseas Chinese Students, and the Overseas Community Affairs Council will review the identity.
3. Students who have applied or been admitted, if found by the Overseas Community Affairs Council or the Ministry of Education to be non-compliant with identity qualifications, or if the submitted documents are found to be false, forged, misused, altered, or legally invalid, will have their application, admission, student status, or graduation qualification and degree certificate revoked, and no academic certificate will be issued.

VI. Required Documents and Proofs

Applicants must submit the following documents in the prescribed manner and time. Non-Chinese or non-English documents should be translated into Chinese or English and verified by Taiwan embassies or Recommendation Units Authorized by the Overseas Community Affairs Council.

1. **Document Checklist:** Place it as the first page of the application file.
2. **Application Form:** The photo should use a high-resolution color image of a 2-inch full-face photograph taken within the last 6 months, without a hat (vertical 4.5 cm, horizontal 3.5 cm).
3. **Language Ability:** If you attach Chinese proficiency test scores, proof of Chinese course completion, or a letter of autobiography in Chinese, priority will be given to the review.
4. **Declaration of Identity and Academic Qualifications:** **All applicants** must complete this form.
5. **Eligibility Confirmation Form for Hong Kong/Macao Residents:** Only for **Hong Kong/Macao students**.
6. **Declaration for Hong Kong/Macao Students with Foreign Nationality without Household Registration in Taiwan:** Only for **Hong Kong/Macao students** with foreign nationality.

7. **Student Identification Documents:**

Overseas Chinese students: Submit a photocopy of either the residence card, the foreign passport, or the Taiwan passport with overseas Chinese status endorsement.

Hong Kong/Macao students (including Hong Kong/Macao students with foreign nationality):

- (1) A photocopy of the permanent residence document of Hong Kong/Macao.
- (2) Hong Kong/Macao students born in Mainland China must also upload a photocopy of the personal data page of the " Mainland Travel Permit for Hong Kong and Macao Residents " (Home Return Permit).

8. **Proof of Enrollment or Graduation Certificate:**

- (1) **Current Graduating Students:** Submit a photocopy of the current semester student ID card or proof of enrollment with the school's official stamp. You must obtain the official graduation certificate before enrollment (**by September 2025**) and translate it into Chinese (exempt for English documents). Otherwise, your application will be deemed ineligible, and the admission will be canceled.
- (2) **Non-Current Graduating Students:** Upload a photocopy of the high school graduation certificate with the school's official stamp.
- (3) You must submit or upload the degree (graduation) certificate verified by Taiwan embassies or Recommendation Units Authorized by the Overseas Community Affairs Council. Otherwise, your application will be deemed ineligible, and the admission will be canceled.

9. **Academic Transcripts:**

- (1) Upload **high school** academic transcripts for **all years**.
- (2) Applicants may also submit local high school examination results such as "Hong Kong Diploma of Secondary Education (DSE)," "Malaysia SPM, STPM results or Private Chinese Secondary Schools Unified Examination Certificate," "IGCSE International General Certificate of Secondary Education," "Overseas A-Level diploma results," or "International Baccalaureate Diploma Programme (IBDP)" along with the high school transcripts. All academic transcripts must be issued by the school, stamped with the official school seal, and **translated into Chinese (exempt for English documents)**. Otherwise, your application will be deemed ineligible, and the admission will be canceled.

10. **Statement of Purpose and Autobiography:** Must be written in Chinese or English.

11. **Statement of Purpose and Autobiography:** Must be written in Chinese or English.

12. **Other Supporting Documents:** Awards, extracurricular activities, student leadership roles, or other prestigious university admission offers.

VII. Admission Principles

Documents not in Chinese or English must be translated into Chinese or English, the translated documents should be stamped by the school.

1. Admission will be conducted through **document review**. If necessary, telephone or video interviews may be conducted to assist the review.
2. The minimum admission standards for each department will be determined by the university's International Student Admission Committee. Applicants who meet the minimum standards but are not admitted may be placed on the waiting list. If the applicants do not meet the minimum standards, they will not be admitted, and the quotas will not be filled.

VIII. Withdrawal of Application

Applicants who wish to withdraw their application for the **fall semester** admission must notify the school via email (isadmission@hk.edu.tw) **before the application deadline (First batch: December 31, 2024; Second batch: July 4, 2025)**.

IX. Announcement of Results

1. **Announcement Date:**

First batch: February 28, 2025.

Second batch: August 1, 2025

2. **Announcement Method:** Results will be published on the Hungkuang University International Affairs Office website: <https://csc.hk.edu.tw/>
3. Applicants should check the results themselves and notify the school of their intention to enroll via email (isadmission@hk.edu.tw) upon receiving admission.

X. Regulations for Studying in Taiwan

1. Overseas Chinese and Hong Kong/Macao students admitted through this channel are not allowed to transfer or enroll in various supplementary and continuing education schools (including night school and weekend program), open universities, or post-baccalaureate programs conducted by universities and colleges. However, Overseas Chinese and Hong Kong/Macao students who have obtained legal residency in Taiwan for reasons other than study may enroll in in-service master's programs. Students who violate these regulations will have their student status canceled, and no academic certificates will be issued. If discovered after graduation, their graduation qualifications will be revoked, and their degrees will be rescinded.
2. Admitted students must comply with the relevant regulations of the Ministry of Education and the university's academic rules.
3. Overseas Chinese students, Hong Kong/Macao students, and Hong Kong/Macao students with foreign nationality should follow the procedures below:

(1) Overseas Chinese Students:

Students holding a foreign passport must apply for a resident visa at the Taiwan embassy or consulate with the following documents: passport (valid for more than 6 months), two 2-inch color photos with white background taken within the last 6 months, visa application form (downloaded and signed after completing it online on the Bureau of Consular Affairs website), admission notice, health certificate issued within the last 3 months by a qualified hospital recognized by the Ministry of Health and Welfare or the Taiwan embassy, visa fee, and other required documents. After entering Taiwan, they must apply for an Alien Resident Certificate at the National Immigration Agency within 15 days.

- i. Nationals without household registration in Taiwan should prepare the following documents in the residing country:
 - A. Application form (with one photo, following the ID card specifications).
 - B. Identity proof from the residing country.
 - C. Taiwan passport or other documents proving Taiwan nationality.
 - D. Police record certificate from the residing country (exempt for minors if the residing country does not issue such certificates).
 - E. Health certificate issued within the last 3 months by a qualified hospital recognized by the Ministry of Health and Welfare or the Taiwan embassy.(For detailed inspection items, please visit the website of the Taiwan Centers for Disease Control, Ministry of Health and Welfare: <https://www.cdc.gov.tw/> select Diseases & Conditions/Foreigner's Health/Items Required for Certificate for Residence in Taiwan).
 - F. Admission letter and other relevant documents. Apply at the Taiwan embassy to be forwarded to the National Immigration Agency, which will issue a single-entry permit and a copy of the Alien Resident Certificate. After entering Taiwan, apply for the Alien Resident Certificate within 15 days. Those already in Taiwan may apply directly at the National Immigration Agency with the required documents.
 - G. Nationals who have previously registered household registration in Taiwan, canceled it upon departure, and have not lost Taiwan nationality or Taiwan Area residency should apply for household registration at the local Household Registration Office within 30 days of staying in Taiwan for more than 3 months and simultaneously apply for the national ID card.

(2) Hong Kong/Macao Students:

Submit an entry application form (with one 2-inch color photo with white background), a photocopy of the Hong Kong/Macao permanent residence document, and apply for an entry permit at the Taipei Economic and Cultural Office of Hong Kong or Macao, or apply online for an entry permit. Admitted students should submit the application for a Taiwan Alien Resident Certificate at the National Immigration Agency with the following documents: entry permit, one 2-inch color photo with white background (same as the national ID card specifications), admission letter, a photocopy of the Hong Kong/Macao permanent residence document, police record certificate from Hong Kong/Macao (exempt for those under 20), health certificate, entry permit processing fee, and a school letter from the International Affairs Office of Hungkuang University.

(3) **Hong Kong/Macao Students with Foreign Nationality:**

Apply for a resident visa at the Taiwan embassy or consulate with the following documents: original foreign passport (valid for more than 6 months) and a photocopy of the personal data page, two 2-inch color photos with white background taken within the last 6 months, visa application form (downloaded and signed after completing it online on the Bureau of Consular Affairs website), admission notice, highest academic degree certificate and transcripts, financial proof, health certificate issued within the last 3 months by a qualified hospital recognized by the Ministry of Health and Welfare or the Taiwan embassy, visa fee, and other required documents. After entering Taiwan, apply for an Alien Resident Certificate at the National Immigration Agency within 15 days.

XI. Registration and Other Instructions

1. Admitted students will receive the "Registration Notice" by Mid September 2025. Please follow the specified time to register at the university with the following documents:
 - (1) Passport (original for verification, photocopy for submission).
 - (2) Permanent or long-term residence documents from the residing country (original for verification, photocopy for submission).
 - (3) High school graduation certificate (or equivalent academic proof) and transcripts, verified by the Taiwan embassy or Recommendation Units Authorized by the Overseas Community Affairs Council.
2. For any questions regarding registration and verification procedures, please contact the International Affairs Office of Hungkuang University.
3. **[Admission does not guarantee visa issuance. Visas must be obtained from the Taiwan embassy.](#)**
4. If an admitted student is found to be ineligible, or if the submitted documents or proofs (including academic qualifications, transcripts, extracurricular activities, and other related proofs) are found to be forged, altered, borrowed, misused, false, or tampered with, their admission will be canceled. If already enrolled, the student will be expelled and held legally responsible, and no academic certificates will be issued. If discovered after graduation, the degree certificate will be revoked, and the graduation qualification will be publicly annulled.
5. After enrollment, admitted students must comply with the relevant regulations of the Ministry of Education and the academic rules of the university.
6. Matters not covered in these guidelines will be handled according to the university's relevant regulations or the decisions of the International Student Admission Committee.

Notice on the Collection, Processing, and Use of Personal Data of Applicants

According to the "Personal Data Protection Act" of the Republic of China (hereinafter referred to as the PDPA), please read carefully the following "Notice on the Collection, Processing, and Use of Personal Data of Applicants " provided by Hungkuang University (hereinafter referred to as HKU) in accordance with Articles 8 and 9 of the PDPA.

1. Institution Name: Hungkuang University

2. Purpose of Collecting Personal Data:

The purposes include the administration of examination-related affairs for various departments (134), providing examination results, admissions, distribution, verification, information services (135), information and database management (136), educational research and statistical analysis (157), student data management (158), academic research (159), or other purposes agreed upon by the applicants.

3. Methods of Collecting Personal Data:

In addition to the basic data, this includes health records (C111) and examination records (C057) required for applicants applying for special examination services (such as those with disabilities or sudden illnesses).

5. Processing and Use of Personal Data:

(1) Duration of Use:

The period of use is the time necessary to achieve the purposes of collection, unless otherwise stipulated by laws or central industry competent authorities regarding the retention period of examination personal data.

(2) Geographical Area of Use:

Taiwan area (including Penghu, Kinmen, and Matsu) or other areas authorized by the applicants.

(3) Targets of Data Use:

Besides HKU's various units (including administrative and academic units), this also includes travel insurance companies.
